Code of Ethics for the Yavapai County Community Organizations Active in Disaster



Preamble

As dedicated professionals committed to serving and protecting the public in times of crisis and emergency, we adhere to the following code of ethics. Our fundamental principles of integrity, compassion, and professionalism guide our actions, ensuring that we fulfill our responsibilities with unwavering dedication and the highest standards of conduct without discrimination.

1. Duty to Serve:
